We want to call to your attention the Group Parts Book Revision Sheets-Form No. 9903; and the Parts Price List Revision Sheets-Form No. 9904, which are issued by the Factory Parts Specification Division.

The Group Parts Book Revision Sheets are used to give you corrections, revisions or additions to the yearly Group Parts Books, Master Chassis and Master Body Parts Books. The heading on the sheet, as well as the number, denotes to what particular book the Revision Sheet applies.

The Parts Price List Revision Sheets are used to give you changes or corrections in parts prices. These sheets are numbered consecutively so that you may know whether or not you have missed any.

These two forms are more convenient than regular parts bulletins for the purposes for which they are intended. The size-8" x 10-1/2" makes them suitable for inserting in the book if you desire to do so. Information contained in each Revision Sheet is of one kind only. No variety of matter is included as is sometimes the case with regular bulletins. Each sheet is punched to fit your standard three ring binder.

In re-conditioning used cars, one of the most important appearance items is the front floor mat. A torn and dirty mat immediately puts the "old car" stamp on an otherwise attractive automobile, while by the same token a neat mat will help to Make the sale. To meet the demand for a good looking mat at a price which would permit its use in all used Hudson and Terraplane cars, we made available in 1939 a Universal Type Mat suitable for use on cars from 1933 to 1939 inclusive. The outline of the mat as well as the necessary holes may be cut to fit the body in which it is being used.

This has been a very popular number, and is continued for use in cars from 1933 to 1939 inclusive.

Due to a difference in contour of the floor, the front floor mat BO 137100 is not suitable for 1940 and 1941 models. We have, however, recently made available a mat for these models which is the same as the production mat, except that it is of somewhat lighter rubber.

The factory Parts Department supplies body lacquer in all of the standard colors for 1942 or earlier cars. The virgin lacquer is supplied in 1/4 pint, 1/2 pint, pint, quart, and gallon containers.

Order lacquer by name and part number, and specify the quantity desired. Use a regular parts order form, but do not include lacquer on the same order sheet with other parts.

Distributors used the order pad for ordering their initial stock of 1942 parts from the factory.

In the 1942 Group Parts Book are listed the service replacement parts for all 1942 passenger and business cars. The parts are arranged in groups according to the Hudson grouping system. Illustrations are provided to assist in identifying parts. This 1942 Group Parts Book was sent to all Distributors, Dealers, and Service Station Agreement Holders in September, 1941.

**GARAGE

One of the pieces which has been effective in assisting Distributors and Dealers to secure more parts business from independent shops and garages, is the Garage Parts List. This booklet shows part numbers, names, prices and models of all "F" parts; also many accessories and shop supplies for Hudson built cars.

The Garage Parts List is published at least twice a year. The current issue - No. 24 - is dated May 1, 1941; and a new issue - No. 25 - will be ready for distribution on November 25, 1941.

POLISHED  
STEEL  
REPLACE-  
MENT  
MOULDINGS

Due to regulations prohibiting the use of chromium for plating of body mouldings, it may be necessary for us, on future orders for chrome mouldings, to supply them in polished steel without plating. Whether or not this substitution is made depends of course on our stock of the original chrome plated type of the particular moulding ordered.

Therefore, in ordering chrome mouldings, continue to use the regular part number of the part desired. In case this is not available we will ship the polished type.

PROTEC-  
TION IN  
STOCK AND  
SERVICE

These Polished mouldings will be shipped to you with a coating of special protective substance, and encased in paper. In this condition, they may remain in stock indefinitely. Before the moulding is installed on a car, the protective coating must be removed by washing thoroughly in gasoline.

Also, either before or after installation, the moulding should be given a coat of high quality clear air dry lacquer or clear synthetic enamel, in order to protect the polished surface while in use. This of course will not afford permanent protection, as in service the lacquer will become chipped or worn off. It is advisable to renew the coat of lacquer at intervals of not greater than six months.

One of the best lacquers we know of for this purpose is specially made by The Glidden Company, and is known as "Glidden Motor Car Lacq." We can supply this through the Parts Department in one-half pint containers, under part number C 205826, at the following net price:
